ELECTIONS - BYE ELECTION TO THE TELANGANA LEGISLATIVE COUNCIL FROM MAHABUBNAGAR LOCAL AUTHORITIES' CONSTITUENCY - ECI, NEW DELHI NOTIFICATION - RESCHEDULING THE DATE OF COUNTING OF VOTES & DATE OF COMPLETION OF ELECTION.

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110001, Dated: 01<sup>th</sup> April, 2024, Chaitra 12, 1946 (Saka) is published.

**NOTIFICATION**

**No.100/TL-LC/11/2023-LAC,-** WHEREAS, on 26.02.2024, the Election Commission of India announced bye election to the Telangana Legislative Council from Mahabubnagar Local Authorities' Constituency, which were notified vide Notification No. 100/TL-LC/11/2023-LAC, dated 04.03.2024, and

2. Whereas, vide said Notification dated 04.03.2024, the poll was fixed for 28<sup>th</sup> March, 2024 and the date before which the said bye election is to be completed was fixed as 04<sup>th</sup> April, 2024. The date for Counting of Votes for said bye election was fixed as 02<sup>nd</sup> April, 2024 vide Press Note dated 26.02.2024.

3. Whereas, in the meantime, General Election to the House of People, 2024 has been announced vide press note dated 16.03.2024. As per the schedule, the date of poll in the last (Seventh) phase is on 01.06.2024. Model Code of Conduct has come into force w.e.f. 16.03.2024.

Further, the administrative machinery involved in conduct of ongoing bye election to Telangana Legislative Council from Mahabubnagar Local Authorities' Constituency is also involved in the ongoing General Election to Lok Sabha, 2024. Engaging it for the conduct of counting of votes of above said election may compromise the smooth processing of conduct of Lok Sabha Election in the State.

4. Whereas, Section 153 of the Representation of the People Act, 1951 specifies that the Election Commission for reasons which it considers sufficient, may extend the time for the completion of any election by making necessary amendments in the notification issued by it under Section 30 or sub-Section (1) of Section 39 of the said Act.

5. Whereas, having considered all aspects of the matter, the Commission has decided to reschedule the date for counting of votes and the date before which the election shall be completed in respect of the bye election to the Telangana Legislative Council from Mahabubnagar Local Authorities' Constituency, as per following schedule:

Events	Date
Counting of Votes	02 <sup>nd</sup> June, 2024 (Sunday)
Date before which election shall be completed	05 <sup>th</sup> June, 2024 (Wednesday)

6. Now, therefore, in view of the above, in exercise of the powers vested under Article 324 of the Constitution of India read with Section 153 of the Representation of the People Act, 1951, the Election Commission hereby makes amendment in its notification No. 100/TL-LC/11/2023-LAC, dated 04.03.2024 as under:

sub-para (e) of para (B) of the said notification shall be substituted with

“(e) the 05<sup>th</sup> June, 2024 (Wednesday), as the date before which the election shall be completed;”
