ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 149, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 FOR THE BYE-ELECTION TO THE HOUSE OF THE PEOPLE FROM 6-MEDAK PARLIAMENTARY CONSTITUENCY.

The following notification No.100/TLNG-HP/1/2014 of the Election Commission of India, New Delhi, dated:20<sup>th</sup> August, 2014 / 29 Shravana, 1936 (Saka) is re-published:-

**NOTIFICATION**

No.100/TLNG-HP/1/2014: - **Whereas**, the seat of Shri Kalva Kuntla Chandrasekhar Rao in the House of the People from the State of Andhra Pradesh, elected from 6-Medak Parliamentary Constituency has become vacant on 29.05.2014, by reason of his resignation; and

2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;
3. **Now, therefore**, in pursuance of sub-section (1) of Section 149, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
  - (A) **Calls upon** the said 6-Medak Parliamentary Constituency in the State of Telangana to elect, before the 19<sup>th</sup> September, 2014 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the House of the People; and

**(B) Appoints**, with respect to the said election -

- (a) the 27.08.2014 (Wednesday), as the last date for making nominations;
- (b) the 28.08.2014 (Thursday), as the date for the scrutiny of nominations;
- (c) the 30.08.2014 (Saturday), as the last date for the withdrawal of candidatures;
- (d) the 13.09.2014 (Saturday) as the date, on which a poll shall, if necessary, be taken;
- (e) the 19.09.2014 (Friday), as the date before which the election shall be completed, and

**(C) Fixes the hours** from **7.00 A.M.** to **6.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
