113-PALAIR ASSEMBLY CONSTITUENCY.

The following notification of the Election Commission of India, New Delhi, No. 100/TEL-LA/2/2016, dated
22nd April, 2016 / 2 Vaisakha, 1938 (Saka) is published:-

NOTIFICATION

No.100/TEL-LA/2/2016: - Whereas, the seat of Sri Ramreddy Venkata Reddy, in the Legislative Assembly
of the Telangana State, elected from 113-Palair Assembly Constituency has become vacant on 4th March, 2016, by
reason of death; and

Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

Now, therefore, in pursuance of Section 150, Sections 30 and 56 of the Representation of the People Act,
1951 (43 of 1951), the Election Commission of India hereby:-

(A) Calls upon the said 113-Palair Assembly Constituency in the State of Telangana to elect, before the 21st May, 2016 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) Appoints, with respect to the said election -

- (a) the 29th April, 2016 (Friday), as the last date for making nominations;
- (b) the 30th April, 2016 (Saturday), as the date for the scrutiny of nominations;
- (c) the 2nd May, 2016 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 16th May, 2016 (Monday), as the date, on which a poll shall, if necessary, be taken;
- (e) the 21st May, 2016 (Saturday), as the date before which the election shall be completed; and

(C) Fixes the hours from 7.00 A.M. to 6.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
