Comments of the Expenditure Observer, if any.

1. A revision of the Expenditure recorded in the Shadow Observation Registers maintained in respect of each of the contesting candidates was necessiated on account of the following reasons:

(a) The notified/prescribed rates of meals was revised downward by the DEO vide Order issued from Ref.H4/1919/2012 dated 21/06/2012 and


(b) The rates of vehicles used in election campaign, by Shri Thota Trimurthulu, INC candidate were initially adopted by taking the notified/prescribed for petrol vehicles. Later on vide letter Ref. D/197/2012 dated 25/06/2012 issued by Tahsildar, Ramachandrapuram it was clarified that all the vehicles used by INC were diesel vehicles.

2. Except for the INC candidate no other candidate has made any payments by cheque.

3. The candidates have generally understated their election expenditure by either not adopting the notified rates or by not declaring certain expenditure at all, though there is video evidence to the effect.
