2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **Now, therefore**, in pursuance of sub-section (2) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 186-Polavaram (ST) Assembly Constituency in the State of Andhra Pradesh to elect, before the 18th June, 2012 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person of the Schedule Tribe of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
