2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **Now, therefore**, in pursuance of sub-section (2) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 186-Polavaram (ST) Assembly Constituency in the State of Andhra Pradesh to elect, before the 18<sup>th</sup> June, 2012 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person of the Schedule Tribe of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

- (B) Appoints, with respect to the said election -
  - (a) the 25.05.2012 (Friday), as the last date for making nominations;
  - (b) the 26.05.2012 (Saturday), as the date for the scrutiny of nominations;
  - (c) the 28.05.2012 (Monday), as the last date for the withdrawal of candidatures;

  - (e) the 18.06.2012 (Monday), as the date before which the election shall be completed, and

(C) Fixes the hours from 8.00 A.M. to 5.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
