 - (b) the 26.05.2012 (Saturday), as the date for the scrutiny of nominations;
 - (c) the 28.05.2012 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 12.06.2012 (Tuesday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 18.06.2012 (Monday), as the date before which the election shall be completed, and

(C) Fixes the hours from 8.00 A.M. to 5.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
