BYE-ELECTION TO THE TELANGANA LEGISLATIVE COUNCIL BY THE MEMBERS OF LEGISLATIVE ASSEMBLY.

The following Notification of the Election Commission of India, New Delhi, No.100/TL-LC/3/2016 (1), dated: 26th September, 2016/Asvina 4, 1938 (Saka) is published:-

**NOTIFICATION**

**No.100/TL-LC/3/2016 (1) :-** Whereas, the seat of Shri Tummala Nageswara Rao in the Legislative Council of the State of Telangana, elected by the members of the Legislative Assembly of the State, has become vacant on 23<sup>rd</sup> May, 2016, by the reason of his resignation, before the expiration of his term of office which was up to and including the 3<sup>rd</sup> June, 2021; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of section 151, sub-section (1) of section 39 and section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) Calls upon the members of the Legislative Assembly of the State of Telangana to elect, before 20<sup>th</sup> October, 2016 and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Council of the State;

(B) Appoints with respect to said election, –

- (a) the 3<sup>rd</sup> October, 2016 (Monday), as the last date for making nominations;
- (b) the 4<sup>th</sup> October, 2016 (Tuesday), as the date for the scrutiny of the nominations;
- (c) the 6<sup>th</sup> October, 2016 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 17<sup>th</sup> October, 2016 (Monday), as the date on which a poll shall, if necessary, be taken; and

- (e) the 20<sup>th</sup> October, 2016 (Thursday), as the date before which the election shall be completed; and  
 (C) Fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
