WHEREAS, the seats of ten (10) members of the Legislative Council of the State of Andhra Pradesh, elected
by the members of Legislative Assembly of the State, are due to fall vacant on 29th March, 2013, on the retirement
of those members, on the expiration of their term of office;

AND WHEREAS, a biennial election has to be held for the purpose of filling the above vacancies so arising;

NOW, THEREFORE, in exercise of the powers conferred under section 16 of the Representation of the
People Act, 1951 (43 of 1951) and as recommended by the Election Commission of India, the Governor of
Andhra Pradesh is hereby pleased to call upon the members of the Legislative Assembly of the State, to elect
ten (10) members to the Legislative Council of the State, for the purpose of filling the above vacancies, in
accordance with the provisions of the said Act and of the rules and orders made thereunder.

NOTIFICATION

No. 322/AP -LC/2013 (1) : - WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 4th March, 2013, been pleased to call upon the members of the Legislative Assembly of the State, to elect ten members to the Legislative Council of the State :-

Now, therefore, in pursuance of sub-section (1) of section 39 and section 56 of the said Act, the Election Commission of India hereby –

(A) appoints, with respect to the said election –

- (a) the 11th March, 2013 (Monday), as the last date for making nominations;
- (b) the 12th March, 2013 (Tuesday), as the date for the scrutiny of the nominations;
- (c) the 14th March, 2013 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 21st March, 2013 (Thursday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 25th March, 2013 (Monday), as the date before which the election shall be completed; and

(B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
