NOW, THEREFORE, in pursuance of sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) appoints, with respect to the said election in each of the constituencies, -

- (a) the 4<sup>th</sup> February, 2013 (Monday), as the last date for making nominations;
- (b) the 5<sup>th</sup> February, 2013 (Tuesday), as the date for the scrutiny of the nominations;
- (c) the 7<sup>th</sup> February, 2013 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 21<sup>st</sup> February, 2013 (Thursday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 27<sup>th</sup> February, 2013 (Wednesday), as the date before which the election shall be completed; and

(B) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken, on the date specified above, for the election.
