The following notification of the Election Commission of India, New Delhi, No.322/AP-LC/2013, dated the 18th March, 2013 / Phalguna 27, 1934 (Saka) is published:-

NOTIFICATION

No.322/AP-LC/2013: - WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 18th March, 2013, been pleased to call upon Hyderabad Local Authorities' Constituency, to elect the one member of that Constituency to the Legislative Council of the State of Andhra Pradesh.

NOW, THEREFORE, in pursuance of sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

- (A) appoints, with respect to the said election in each of the constituencies, -
- (a) the 25th March, 2013 (Monday), as the last date for making nominations;
 - (b) the 26th March, 2013 (Tuesday), as the date for the scrutiny of nominations;
 - (c) the 28th March, 2013 (Thursday), as the last date for the withdrawal of candidatures;
 - (d) the 13th April, 2013 (Saturday), as the date on which a poll shall, if necessary, be taken; and
 - (e) the 18th April, 2013 (Thursday), as the date before which the election shall be completed; and
- (B) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
