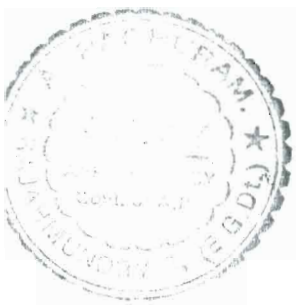

(iv) **Court that framed the charge:** After registering FIR, I was arrested on 01-03-1996, by Excise Police, Korukonda and produced before II Additional Judicial First Class Magistrate on 02-03-1996. During the agitation for prohibition, a demonstration was made with the I D Liquor, which is easily and readily available to show that the Govt is lax, and hand in glove with illicit distillers. As such, no bail petition is filed and consequently, the learned III Additional Judicial First Class Magistrate, Rajahmundry on 02-03-1996 remanded me to judicial custody for 14 days and I was lodged in Central Prison, Rajahmundry. However, the Excise Police, Korukonda on its own filed a petition to release me and the learned III JFCM ordered my release. Subsequently, Excise Police, Korukonda did not file any charge sheet so far. Hence, except registering an FIR, arresting me and subsequently seeking my release, no cognizance is taken and no charge sheet is filed.

(ii) Police Station: Amalapuram Town Police Station, District: East Godavari State: Andhra Pradesh

(iii) Section of the concerned Act and short description of the offence for which the candidate has been charged: Section 309 IPC – Attempt to commit Suicide

(iv) Court that framed the charge: -- Not Applicable – one Jakkampudi Nageswara Rao of Amalapuram died in the midnight of 26-12-1997 in mysterious circumstances at the official residence of Dr Metla Satyanarayana Rao, the then minister of Co-operation in the Government of AP. Everybody suspected fowl play and there was a spontaneous demand for judicial enquiry and stern action against the culprits. Providing benefits on humanitarian grounds to the kin of the bereaved family was also one of the demands. Since no action is taken nor even an assurance was given on these demands, myself and the widow of Jakkampudi Nageswara Rao commenced indefinite hunger strike. Both of us were arrested by Amalapuram Town Police Station and shifted to Government General Hospital, Kakinada. I continued the fast at Government General Hospital, Kakinada while I was under arrest. Subsequently, the Government conceded our demands and appointed a one man commission of enquiry under the commission of enquires act. Thereafter, I gave up the indefinite fast, applied for and obtained bail from I Additional JFCM Amalapuram. Long thereafter, out of political vendetta, a false charge sheet under section 309 of IPC is filed against me on 20-08-1998 and the same is taken on file as C C No 225 of 1998 on the file of the court of I
