### NOTIFICATION

No. 464/AP-HP 2014: - Whereas, the Election Commission of India, by its Notification No. 464/2014 (8) dated 12<sup>th</sup> April, 2014, issued under Section 30 read with Section 56 of the Representation of the People Act, 1951 (43 of 1951) has fixed hours of Poll, in respect of each of the parliamentary constituencies of States, specified in the schedule to the said notification including in respect of 18-Araku(ST) and 31-Narsaraopet Parliamentary Constituencies of the state of Andhra Pradesh; and

Whereas, after considering the report of Chief Electoral Officer, Andhra Pradesh and taking into account all other material circumstances including the Law and Order scenario, the Election Commission of India has decided to change the hours of poll in the assembly segments of the aforesaid Parliamentary Constituencies in the State of Andhra Pradesh;

Now, therefore, in exercise of the powers conferred by Section 56 of the Representation of the People Act, 1951 read with Section 21 of the General Clauses Act, 1897 (10 of 1897), the Election Commission of India hereby makes the following amendments in its Notification No 464/2014 (8) dated 12<sup>th</sup> April, 2014, referred to above namely: -
