2. The Commission has decided to extend the concession sought by the party under the Election Symbols (Reservation and Allotment) Order, 1968. 





I am directed to state that "**Nationalist Congress Party**", a recognized State party in the States of Maharashtra and Nagaland, having reserved symbol '**Clock**' in the said States, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol '**Clock**' to its candidates being set up by the party at the current General Election to the House of the People from all the Constituencies of all the States and UTs (except the states 'Maharashtra' and 'Nagaland' where the party is already recognized).

5 The date of notification for General Elections to the House of the People for the Phase-I was 20.03.2024 and the last date to submit application under Para 10 was 23.03.2024. The application from the party has been received in the Commission on 24.03.2024.

6. In view of above, the request of seeking concession under Para 10 of Election Symbols (Reservation & Allotment) Order,1968, in the said States and UTs for **Phase-I** of Election to the House of the People, has **not been considered**.


