NOTIFICATION

No.322/TL-LC/2017:- WHEREAS, the Governor of the State of Telangana has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 13th February, 2017, been pleased to call upon Mahabubnagar-Ranga Reddy-Hyderabad Teachers' Constituency, to elect one member to the Legislative Council of the State of Telangana.

NOW, THEREFORE, in pursuance of sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) appoints, with respect to the said election in the Constituency, -

- (a) the 20th February, 2017 (Monday), as the last date for making nominations;
- (b) the 21st February, 2017 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 23rd February, 2017 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 9th March, 2017 (Thursday); as the date on which a poll shall, if necessary, be taken; and
- (e) the 18th March, 2017 (Saturday), as the date before which the election shall be completed; and

(B) fixes the hours from 8.00 A.M. to 6.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
