The District Election Officers and Electoral Registration Officers noted in the address entry are aware that the last date for receipt of applications in Form-18 /19 is 05.11.2016. Complaint has been received that number of applications have been received even in the whole night of 5.11.2016 and also online on 6.11.2016 and thousands of applications have been received on the last date and it was requested not to consider the applications after due date and thorough enquiry be made in respect of applications received on the last date and to weed out the applications received from the private school teachers without the countersignature of the DEO / equivalent officer.

All the District Election Officers / Electoral Registration Officers of Council Constituencies are, therefore, requested to process the applications received till the last date for receipt of applications i.e., 5.11.2016 for preparation of draft electoral rolls to be published on 23.11.2016. All the applications received throughout the period of receipt of claims shall be thoroughly verified through the Booth Level Officer or any other Verification Officer and the ERO shall dispose of the application based on the enquiry report after cross checking by the ERO with any other documents in order to satisfy himself that the applicant possesses both the requisite qualification as well as the resident of the Constituency concerned.

They are also aware that as per the ECI instructions, the private aided / unaided teachers are also eligible to be included in the electoral rolls, subject to submission of service certificate issued by the Head of the institution countersigned by the District Education Officer or equivalent officer, along with the Form-19, Hence, any application received without fulfilling the above condition shall summarily be rejected.
