The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110001, Dated: 13th October, 2014/21, Asvina, 1936 (Saka) is republished:-

NOTIFICATION

No. 56/Symbol/2014/PPS-II - In exercise of the powers conferred by Article 324 of the Constitution of India read with Rules 5 and 10 of the Conduct of Elections Rules, 1961, the Election Commission of India hereby makes the following Order to further amend the Election Symbols (Reservation & Allotment) Order, 1968, namely:-

Short Title and Commencement

- (i) This Order shall be called the Election Symbols (Reservation & Allotment) (Amendment) Order, 2014.
- (ii) It shall come in to force with immediate effect.

2. Amendment of Form B

In Form B appended to the Election Symbols (Reservation & Allotment) Order, 1968, in the Table in paragraph 1 pertaining to the name of the constituency and the details of the candidate(s) nominated, for the existing entries in the heading of column (5) thereof, the following entries shall be substituted:

"Name of the substitute candidate who will step in (i) on the approved candidate's nomination being rejected on scrutiny, or (ii) on his (approved candidate) withdrawing from the contest if, however, the nomination paper of substitute candidate is accepted on scrutiny as an independent candidate, and he is still a contesting candidate."
