## PRESS NOTE

Subject: Biennial Elections to the Council of States to fill the seats of members retiring in April-May 2018 and a bye-election to the Council of States from the State of Kerala.

The term of office of 58 members of the Rajya Sabha elected from 16 States is due to expire on their retirement in April-May 2018 as detailed below:

2. Besides above, there is a casual vacancy to the Council of States from Kerala due to the resignation of Shri M.P. Veerendra Kumar on 20.12.2017 before the expiration of his term of office, which is up to and including 02.04.2022.

3. The Commission has decided to hold biennial election from above mentioned 16 States and a bye-election to the Council of States from Kerala in accordance with the following programme: -.

The Commission has directed that for the purpose of marking preference(s) on the ballot paper only integrated violet colour sketch pen(s) of pre-fixed specification, provided by the Returning Officer, shall be used. No other pen shall, under any circumstances, be used in the above said elections.
