The following Notification of the Election Commission of India Nirvachan Sadan, Ashoka Road, New Delhi - 110001, Dated: 13th October, 2025, 21 Ashwin, 1947 (Saka) is published.

NOTIFICATION

No.100/TEL-LA/1/2025 :- Whereas, the seat of **Shri Maganti Gopinath** in the Legislative Assembly of Telangana State, elected from **61-Jubilee Hills** Assembly Constituency has become vacant on **8th June 2025** by reason of his death ; and

Whereas, a bye-election is to be held for filling the vacancy so caused;

Now, therefore, in pursuance of sub-section (1) of Section 150, and Section 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

- (A) Calls upon the **61-Jubilee Hills** Assembly Constituency in the State of Telangana to elect, before the 16th November, 2025 and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
- (B) Appoints, with respect to the said election,
- (a) the 21st October, 2025 (Tuesday), as the last date, for making nominations;
 - (b) the 22nd October, 2025 (Wednesday), as the date, for the scrutiny of nominations;
 - (c) the 24th October, 2025 (Friday), as the last date, for the withdrawal of candidatures;
 - (d) the 11th November, 2025 (Tuesday), as the date, on which a poll shall, if necessary, be taken; and
 - (e) the 16th November, 2025 (Sunday), as the date, before which the election shall be completed; and
- (C) Fixes the hours from 7.00 A.M. to 6.00 P.M. as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
