It is also clarified that the present allotment of symbol in the above-mentioned UT is only for the ongoing Bye-Election to the Legislative Assembly of Jammu and Kashmir. '**Jammu and Kashmir National Panthers Party (India)**' may be treated as a **State Recognized Party** in the UT of Jammu and Kashmir only;
