The attention of the Dist. Collector & Dist. Election Officer and the Returning Officer is invited to the references cited, wherein the Election Commission of India has issued instructions from time to time and latest instructions in the reference 14<sup>th</sup> cited vide Ir.dated 28.02.2019 regarding Amendments in Form-26 (Format of Affidavit by candidates) filed by the candidates in the offices of Returning Officer / Assistant Returning Officer and placing the Affidavits on the ECI & CEO's website. Copies of the same have already been communicated to all District Election Officers from time to time. However, copies of the same are once again enclosed.

2. In the reference 11<sup>th</sup> cited, the ECI has instructed that the candidates are now required to file the affidavit in the amended Form-26 and shall fill up all columns as directed by the Commission. The provisions for the additional affidavit in respect of dues against Govt. accommodation, if any, have now been incorporated in Form-26 itself under Item (8) relating to liabilities to Public Financial Institutions and Govt. Therefore, the candidates shall give the requisite declaration/particulars in this regard in Item (8) of Form-26. Accordingly, the candidates are now not required to file the additional affidavit prescribed under the Commission's Order No.509/11/2004-JS-I, dt.3.2.2016, as the provisions are now part of Form-26 itself.

- 3. The District Election Officer and the R.O. are informed that the Commission has directed that the Affidavits filed by all candidates, whether set up by the recognized political parties or unrecognized political parties or independents shall be put on the website soon after the candidate files the same and within 24 hours in any event. Therefore, all the D.E.O.,/R.O. are, requested to upload the scanned copies of affidavits (format in Form-26) filed by the candidates on daily basis on E.C.I., & C.E.O's website as per ECI instructions. The affidavits should be scanned with high resolution for legible reading.
- 4. In the reference 12<sup>th</sup> cited, the ECI has furnished the FAQs on Criminal Antecedents of candidates and its publicity in pursuance of Hon'ble Supreme Court of India Judgment dated:25.09.2018 in © No.536 of 2011.(copy enclosed).
- 5. In the reference 13<sup>th</sup> cited, the ECI has furnished the revised format of checklist of document in connection with filing of nominations by the candidates in view of the Amendment in Form-26.
- 6. The data entry of the Affidavits and counter-Affidavits has to be done by the concerned Returning Officer from Suvidha portal as per ECI instructions issued in the reference 15<sup>th</sup> cited.
- 7. The District Election Officer / R.O., are requested to take necessary action duly following the ECI's instructions in the references cited. The above instructions are not exhaustive. For detailed instructions the Hand Book for Returning Officers, other Hand Books and latest instructions of the E.C.I. issued from time to time should and also available on ECI website should be referred and followed scrupulously.

Your attention is invited to the Commission's letter No. 3/ER/2004/J.S.-II, dated 1st April, 2004 (copy enclosed). In the said letter, it has been directed that all entries in the two affidavits filed by the candidates at the time of filing of nomination, should be preferably typed out, and if hand-written, the entries should be clearly and legibly written. Further, no columns are to be left blank. If there is no particulars to be indicated against any item, 'NIL', or 'NOT APPLICABLE' as may be appropriate, should be written.

There have been complaints that in many cases, the affidavits filed by the candidates contain vague and illegible entries, and some columns are even left blank. It is requested that the above instructions may be brought to the notice of all concerned including the Returning Officers and all the political parties based in your State, for strict compliance.

The scanning and uploading of the affidavits on the website should be done as early as possible after the nomination is received, and in any case, not later than 24 hrs., so that it serves the intended purpose of providing information to the electors to enable them to make an informed choice. Copy of affidavits should also be made available to anyone desiring it.

Kindly acknowledge the receipt of this letter and direct the Returning Officers to follow it scrupulously.

Please refer to the Commission's order No. 3/ER/2003/JS-II, dated 27<sup>th</sup> March, 2003, and the subsequent instructions issued from time to time regarding filing of affidavits by candidates about their criminal background, assets, liabilities and educational qualifications, and the dissemination of the affidavits for information of the electors.

- 2. As per the existing instructions, copies of the affidavits are to be displayed on the notice board of the Returning Officer immediately after the affidavit is filed and copies of the affidavit are to be supplied free of cost to any person who asks for the same. The affidavits are also required to be scanned and uploaded on the CEO's website, so that the affidavits of all contesting candidates are available immediately after the list of contesting candidates is finalized. In accordance with extant instructions and practice, the information about government dues as given in the affidavit (under the heading 'liabilities') is also published in two newspapers with local circulation.
- For wider dissemination of information contained in the affidavits to the electors,
   the Commission has given the following further directions:

- (ii) In those cases where the offices of the ROs and AROs are both situated outside the boundary of the constituency, one set of copies of affidavits should be displayed on the notice board of the RO and another set should be displayed in some public premises accessible to the general public within the constituency.
- (iii) When the information on government dues is published in the newspaper, there should be a note added therein mentioning the places where the other details viz. criminal background, assets, liabilities and educational qualifications of all the contesting candidates can be found. The note should also mention that the affidavits can be viewed on the website of the CEO and the path to the website should also be mentioned.
- (iv) It should be ensured that the complete set of affidavits in respect of all contesting candidates is available on the website within 24 hours after finalization of the list of contesting candidates. Special care should be taken

to ensure that no part of any affidavit is left out while scanning is carried out.

4. Please communicate these instructions to all officers concerned in the State, and also acknowledge receipt of this letter and confirm action being taken.

Sir/ Madam,

Kindly refer to the instructions issued vide the Commission's letter of even no. dated 08.02.2011 regarding dissemination of the affidavits filed by the candidates for information of the electors. The instructions contained in para 3 (iv) of the said letter was slightly amended vide letter dated 11.01.2012 to the effect that the affidavits filed by the candidates of recognized political parties shall be put up on the website within 24 hours of filing of the affidavit.

- 2. Clarification has been sought regarding uploading of affidavits filed by the other candidates, i.e. candidates of registered political parties and independents.
- 3. It is hereby clarified that the affidavits filed by all the contesting candidates must be available on the website within 24 hours after finalization of the list of contesting candidates. However, the affidavits filed by the candidates of recognized political parties shall be put up on the website within 24 hours of filing of the affidavit without waiting for the preparation of the list of contesting candidates after the last date for

withdrawal of candidature. In such cases, even if any candidate withdraws his candidature, the affidavit already uploaded on the website shall not be removed from there. The affidavits filed by the other candidates (i.e. candidates set up by registered unrecognized political parties and independents) shall be put up on the website within 24 hours after finalization of the list of contesting candidates.

The above clarification may be brought to the notice of all concerned.

Attention is invited to the Commission's letter of even number dated 20th July, 2012 regarding uploading of the affidavits filed by the candidates on the website for dissemination of the information to the electors.

- In the above mentioned letter, it was instructed that the scanned affidavits filed by the candidates of recognized political parties shall be put up on the website within 24 hours of filing of the affidavit and the affidavits filed by the other candidates (I.e. candidates set up by registered unrecognized political parties and independents) within 24 hours after finalization of the list of contesting candidates.
- Now the Commission has reviewed the above instruction and has decided that the affidavit filed by all candidates, whether set up by the recognized political parties or unrecognized political parties or independents shall be put up on the website soon after the candidates file same and within 24 hours in any event. Even if any candidate withdraws his candidature, the affidavit already uploaded on the website shall not be removed.
- These instructions shall be followed at all elections, i.e. general/biennial election and all bye-elections.

Sir/Madam,

As per the directions in the Commission's order No. 3/ER/2003/JS-II, dated 27-03-2003, the affidavits filed by candidates were to be disseminated by displaying copies thereof on the notice board of the Returning Officer and by making copies available freely to those seeking the same. In the said order, it was also directed that if anyone furnishes information countering the statements made by any candidate in his affidavit by means of a duly sworn affidavit, such counter affidavit shall also be disseminated alongwith the affidavit of the candidate concerned in the same manner, i.e. by displaying copy on the notice board and furnishing copies to others on demand.

From the year 2004 onwards, the affidavits of candidates are being uploaded on the website of the CEO. However, the same is not done in respect of counter affidavits filed, if any. The Commission has now decided that henceforth, all counter affidavits (duly notarized) filed by any person against the statements in the affidavit filed by the candidate shall also be uploaded on the website alongwith the affidavit concerned. Such uploading should also be done within 24 hours of filing of the same.

Kindly convey these directions to all DEOs, ROs (including ROs for elections to Council of States and State Legislative Council) and other election authorities concerned with the matter.

\_Sir/Madam,

You are aware that the candidates at elections to the Parliament and State Legislatures are required to file an Affidavit in statutory Form 26 appended to the Conduct of Elections Rules 1961, to disclose, among others, the details of deposit/ investments in bank / financial institutions/non-banking financial institutions etc. and the details of movable and immovable assets and liabilities/dues to public financial institutions and government, in the name of the candidate, spouse and dependent children along with the nomination paper. The format of the said Affidavit in Form 26 was notified by the Ministry of Law & Justice in the Gazette of India Extraordinary issue No.1433 dated 01/08/2012. A copy of the amended Form-26 was forwarded to your party by the Commission vide its letter dated 24th August, 2012 and also communicated to the State units through the Chief Electoral Officer of State/UT concerned.

- 2. It has been brought to the notice of the Commission by some NGOs and individuals that some candidates do not disclose details of their accounts in foreign banks, possession of properties or investment overseas along with loans and liabilities outside the country in the Affidavit.
- 3. The Commission has taken note of the issue and has decided to clarify the matter for the benefit of all stakeholders and to remove any misgivings in the minds of the people. It is accordingly clarified that the "details of Bank accounts, assets and liabilities" to be furnished in the affidavit should in variably include the "details of all deposit/ investments in Foreign banks and any other body / institution abroad, and details of all, assets and tiabilities in foreign countries. Hence, the candidates, should ensure that the furnished full and complete information in this regard in their affidavit.
- 4. The above position may please be noted and brought to the notice of all candidates sponsored by your party for any election to Parliament and State Legislature.

Sir,

All candidates at elections to the two Houses of Parliament and State Legislatures are required to file, among other documents, affidavit in Form 26 appended to the Conduct of Elections Rules, 1961. The Commission, vide its letter dated 491/SM/2013/Communication, dated 25th October, 2013, had instructed that the candidates shall also be asked to furnish information about their Social Media account, if any, in Para 3 of Form 26.

Information about Social Media account being not a part of the statutory format as per Form 26, it is clarified that if a candidate does not add the information pertaining to Social . Media account in Form 26, it is not necessary to ask the candidate to file a fresh affidavit adding the said particulars. In such case, the information about Social Media account, if any, may be obtained from the candidate separately on a plain paper. In any event, non-furnishing of laformation about Social Media account in Form 26 shall not be treated as a ground for considering the affidavit in Form 26 as incomplete or to reject the nomination paper.

The above clarification should be brought to the notice of all Returning Officers in the State including the Returning Officers for Rajya-Sabha elections urgently. In the case of those States where elections to Rajya Sabha and Legislative Councils are in progress now, this clarification should be communicated to the Returning Officers today itself.

have been amended vide Gazette Notification S.O. 1133(E), dated 7th April. 2017 of the Ministry of Law and Justice, Government of India. The Amendment Notification has been circulated vide Commission's letter No. 3/4/ECI/ LET/FUNC/JUD/SDR/Vol.I/2016 dated 17th May, 2017. By the amendment carried out now, the contact telephone numbers, email id, social media accounts of the candidate and source of income of the candidate and spouse have been incorporated in Form 26.

A clarification has been sought by the CEO, West Bengal as to whether the instructions issued vide the Commission's letter no. 3/ER/2016/SDR dated 31<sup>st</sup> May, 2016 that "non furnishing of information about Social Media account in Form 26 shall not be treated as a ground for considering the affidavit in Form 26 as incomplete or to reject the nomination paper", still holds good or not in view of the above said amendment.

It is clarified that the instructions in the Commission's above said letter dated 31st May, 2016, was issued prior to the amendments in Form 26. Now that columns for details regarding phone number, lemail id, social media accounts have been added in Form 26, information in this regard has to be furnished. In the event a candidate does not have any or all of these, he/she should write 'Nil' in these columns. If these columns are left blank, action should be taken as per the instructions in the letter No. 576/3/2013 dated 30th September, 2013 i.e. to ask the candidate to file fresh affidavit with all columns filled up and complete in all respects.

The above clarification may be conveyed to all DEOs/ROs and others concerned. This may also be brought to the notice of all political parties in the State/UT.

It has been directed therein that the candidates are required to fill in all columns in the affidavit and that if there is no specific information to furnish against any column, appropriate remark such as 'Nil', 'Not Applicable' or 'Not Known', as may be appropriate, should be entered against such column.

- 2. It has been brought to the notice of the Commission that in *Note-3* given at the cnd of the format of Form-26, reference has been made only to the options 'Nil' and 'Not Applicable' for cases of the above nature, and that this is likely to create confusion when a candidate makes the entry 'Not Known' against any column in the affidavit.
- It is hereby clarified that in view of the directions in the above-referred Order of the Hon'ble Supreme Court, it would be open to a candidate to make the entry 'Not Known' also in appropriate cases.
- 4. This clarification may be brought to the notice of all Returning Officers including those for elections to the Rajya Sabha and State Legislative Council. This may also be brought to the notice of political parties.

It would be for the R.O to decide the validity of the affidavit in Form26, and for the DEO concerned to decide the validity of the affidavit filed along with the account of election expenses.
- 4. This may be brought to the notice of all DEOs, ROs & AROs and to all the political parties based in your State/UT.

Sub:- (i) Supreme Court's Judgment on the petition regarding people with criminal antecedents contesting elections;

(ii) Amendments in Form-26 (Format of affidavit by candidates).

Sir/Madam,

The candidates at all elections are required to file affidavit in Form-26, along with nomination paper, declaring information about criminal cases, assets, liabilities and educational qualifications. Form-26 has now been amended vide Ministry of Law & Justice Notification No. H.11019(4)/2018-Leg.II, dated 10<sup>th</sup> October, 2018. The amendments made in Form-26 are in pursuance of the directions in the judgements of the Hon'ble Supreme Court in Writ Petition(C) No. 784 of 2015 (Lok Prahari Vs. Union of India & Others) and Writ Petition (Civil) No. 536 of 2011 (Public Interest Foundation & Ors. Vs. Union of India & Anr.). A copy of the said notification along with a copy of the updated Form-26 is enclosed herewith. The candidates are now required to file the affidavit in the amended Form-26.

- In the judgement in Writ Petition (Civil) No. 536 of 2011, the Hon'ble
   Supreme Court has, inter alia, given the following directions:-
- " (i) Each contesting candidate shall fill up the form as provided by the Election Commission and the form must contain all the particulars as required therein.
  - (ii) It shall state, in bold letters, with regard to the criminal cases pending against the candidate.
  - (iii) If a candidate is contesting an election on the ticket of a particular party, he/she is required to inform the party about the criminal cases pending against him/her.

(iv) The concerned political party shall be obligated to put up on its website the aforesaid information pertaining to candidates having criminal antecedents.

(v) The candidate as well as the concerned political party shall issue a declaration in the widely circulated newspapers in the locality about the antecedents of the candidate and also give wide publicity in the electronic media. When we say wide publicity, we mean that the same shall be done at least thrice after filing of the nomination papers."

- 3. In pursuance of the abovementioned judgement, the Commission, after due consideration, has given the following directions to be followed by candidates at elections to the Houses of Parliament and Houses of State Legislatures who have criminal cases against them, either pending cases or cases of conviction in the past, and to the political parties that set up such candidates:
  - (a) Candidates at elections to the House of the People, Council of States, Legislative Assembly or Legislative Council who have criminal cases against them either pending cases or cases in which candidate has been convicted, shall publish a declaration about such cases, for wide publicity, in newspapers with wide circulation in the constituency area. This declaration is to be published in Format C-1 attached hereto, at least on three different dates from the day following the last date for withdrawal of candidatures and upto two days before the date of poll. The matter should be published in font size of at least 12 and should be placed suitably in the newspapers so that the directions for wide publicity are complied with in letter and spirit.

(Illustration: If the last date for withdrawal is  $10^{th}$  of the Month and poll is on  $24^{th}$  of the Month, the publishing of declaration shall be done between  $11^{th}$  and  $22^{nd}$  of that Month).

(b) All such candidates with criminal cases are also required to publish the above declaration on TV channels on three different dates during the abovementioned period. But, in the case of the declaration in TV Channels, the same should be completed before the period of 48 hours ending with the hour fixed for conclusion of poll.

- (c) In the case of all candidates who have criminal cases as per the declarations in Items 5 and 6 of Fom-26, the Returning Officer shall give a written reminder about the directions herein for publishing declaration about the criminal cases in newspapers and TV channels for wide publicity. A standard format for such reminder to the candidates is annexed as Format C-3. The candidates shall submit the copies of newspapers in which their declaration in this regard was published to the District Election Officer, along with their account of election expenses.
- (c) In the case of candidates with criminal cases set up by political parties, whether recognized parties or registered un-recognized parties, such candidates are required to declare before the Returning Officer concerned that they have informed their political party about the criminal cases against them. Provision for such declaration has been made in Form-26 in the newly inserted Item (6A).
- 4. The Political Parties recognized parties and registered un-recognised parties, which set up candidates with criminal cases, either pending cases or cases of past conviction, are required to publish declaration giving details in this regard on their website as well as in TV channels and newspapers having wide circulation in the State concerned. This declaration by political parties is to be published in Format C-2, annexed hereto. Publishing of the declaration in newspapers and TV channels is required to be done atleast on three different dates during the period mentioned in Para-2(a) above. In the case of TV channels, it shall be ensured that the publishing should be completed before the period of 48 hours ending with the hour fixed for conclusion of poll for the election. All such political parties shall submit a report to the Chief Electoral Officer of the State concerned stating that they have fulfilled the requirements of these directions, and enclosing therewith the paper cuttings containing the declarations published by the party in respect of the State/UT concerned. This shall be done within 30 days of completion of

election. Thereafter, within the next 15 days, the Chief Electoral Officer should submit a report to the Commission confirming compliance by the parties concerned, and pointing out cases of defaulters, if any.

- 5. It may also be noted that the provisions for the additional affidavit in respect of dues against Govt. accommodation, if any, that may have been allotted to the candidates, have now been incorporated in Form-26 itself under Item (8) relating to liabilities to Public Financial Institutions and Govt. Therefore, the candidates shall give the requisite declaration/particulars in this regard in Item (8) of Form-26. Accordingly, the candidates are now not required to file the additional affidavit prescribed under the Commission's Order No. 509/11/2004-JS-I, dated 3<sup>rd</sup> February, 2016, as the provisions are now part of Form-26 itself.
- 6. This letter may be circulated to all DEOs, ROs in the State/Union Territory for necessary action on their part. This shall also be circulated to all the political parties based in the State, i.e. the State Units of the recognized Parties and recognized State parties of other States and all registered un-recognized political parties with headquarters based in your State/Union Territory, with instructions to take note of the above directions and the amendments in Form-26.

- In the Commission's abovementioned letter, it has been inter alia, directed that after the election the candidates shall submit a report about publishing of declaration to the DEO and the Political parties to the CEO of the State. The Commission has provided formats C-4 and C-5 for this purpose. The formats are also enclosed. These shall also be circulated to the DEOs, ROs and all political parties based in the State.

FAQs: Criminal Antecedents, if any, of a candidate and its publicity in pursuance of Hon'ble Supreme Court judgement dated 25-09-2018 in WP (Civil) No. 536 of 2011.

Q.1 Which newspapers are to be chosen for publicity by such candidates?

Ans. As per direction in the judgement of the Hon'ble Supreme Court, the declaration is required to be published in newspapers with wide circulation in the area concerned. The CEO may get an indicative list of various newspapers which have wide circulation in the various district/different constituency areas in the State prepared by the State DIP. This indicative list should be shared with the political parties and the candidates.

Q.2 When has it to be publicised?

Ans. It has already been clearly mentioned in the Commission's letter dated 10-10-2018 that the publishing has to be during the period starting from the day following the last date for withdrawal of candidature and up to two days before the date of poil.

Q.3 There is no column for signature. Who will authenticate it?

Ans. The format contains column for mentioning the name and address of the candidate and the name of the political party on the top portion of the format. Thus, the name of the publisher will be clear from the declaration. There is no need for publishing the information with the signature of the publisher.

Q.4 What if someone publishes false information about criminal cases of another candidate?

Ans. There are already provisions to deal with any case of publication of false statement in relation to a candidate [Section 123 (4) of the RP Act, 51 and Section 171G of IPC].

Q.5 Which TV channel the declaration has to be publicised?

Ans. Please refer to the answer against Q.1 above. It has to be done in TV channels which are available/popular in the areas concerned.



Q.6 What will be the font size and duration of publicity in TV?

Ans. Font size should be the standard size used for displaying printed material on TV. Its duration may not be less than 7 seconds.

Q.7 If a candidate does not have any criminal record, whether he/she is required to publicise?

Ans. No. Only those candidates who have either pending criminal cases or who have been convicted in the past are required to publish the declaration.

Q.8 Whether FIR cases have to be published by the concerned candidates and political parties?

Ans. Yes. Under the heading 'Case No. and status of case', details regarding FIRs, mentioned in Item-5 of Form-26, are required to be mentioned.

Q.9 If after filing nomination, status of criminal case changes, whether candidate can revise the details?

Ans. It will be open to the candidate concerned to notify the revised status to the Returning Officer and to publish that revised status only. If it is NIL, the candidate is not required to publish it.

Q. 10 Who will bear the expenses for publishing?

Ans. Expenses, if any, will be borne by thecandidate and the political parties in respective cases.

Q. 11 Whether expenditure on this account will be accounted for?

Ans. Yes. This being an expenditure in connection with the election, if expense is incurred in this regard, the same will be counted for the purposes of election.

Q.12 Can RO act on any discrepancy in such details if pointed out?

Ans. No. RO is not supposed to enquire into correctness of declarations published by candidate/political parties.

Q.13 In what manner, such candidates will submit the information about publicity of cases to the DEO?

Ans. Separate formats have been specified by the Commission for the candidates and the political parties to submit report about publishing of the declaration. These are Format-C-4 for candidates and Format-C-5 for political parties.

Q.14 What happens if such candidates or such political parties do not publicise in the manner prescribed?

Ans. Such failure may be a ground for post-election action like election petition or contempt of Hon'ble Supreme Court.

- 2. In the Conduct of Elections Rules, 1961 in FORM 26,—
- I. in PART A-
  - (i) for paragraph (4) and the Table thereunder, the following shall be substituted, namely:—
  - "(4) Details of Permanent Account Number (PAN) and status of filing of income tax returns

Subject: General Election to House of People, 2019 – Uploading of Affidavits/Counter Affidavits filed by candidates and others along with nomination papers.

i∕/Madam,

As you are aware, Election Commission of India has started new Suvidha' application, which is an integral platform for candidate nomination, candidate Affidavits, permissions, counting and results.

- 2. As part of hew Suvidha' application for display of Affidavits and counter-Affidavits, the Commission has launched the URL https://affidavits.eci.gov.in, the link of which will be available from the ECI main website. The data entry of the Affidavits and counter-Affidavits has to be done by the respective Returning Officers from Suvidha portal. Following things should be kept in mind in this regard:
  - (i) The Affidavits and other documents as part of the ECI's instructions should be combined together in one PDF format after scanning.
  - (ii) The size of the PDF should not be more than 10 mb.
  - (iii) The quality of the scanning should be more than 100 dpi.
  - (iv) These Affidavits should be uploaded immediately along with nomination papers, but not later than 24 hours.
  - (v) The CEOs should also give the link of the Affidavit Portal in their respective CEO Website.
- 3. All the District Election Officers of Parliamentary Constituencies and Assistant Returning Officers should be instructed accordingly. Any non-compliance or delay in uploading of Affidavits will be taken seriously by the Commission. Officers at the CEO Office should continuously monitor and ensure the compliance.

4. The above instructions may be brought to the notice of all concerned immediately.
