In pursuance of rule 31 (3) of the Registration of Electors Rules, 1960 each of the Electoral Registration Officers whose particulars appear in the First Schedule below hereby calls upon every person entitled to be registered in the electoral roll of the constituency mentioned in the said Schedule to send to or deliver at his Office, on or before 6th November, 2012 at the latest, an application in Form 19 appended to the Registration of Electors Rules, 1960 and reproduced in the Second Schedule below, for inclusion of his/her name.

- The applications may also be sent to the Assistant Electoral Registration Officers / Designated Officers whose particulars are shown in the First Schedule.
- 3. All persons whose names are included in the existing rolls for these constituencies should also submit fresh applications in the prescribed forms, to enable the ERO to verify the present eligibility of the applicant in terms of Article 171(3)(c) of the Constitution read with Sections 27(3)(c), 27(5)(b) and 27(6) of the Representation of People Act, 1950.
- 4. Qualifications: Every person who is a citizen of India, and is ordinarily resident in the constituency and has, within the six years immediately before 1st November, 2012, been engaged for a total period of at least three years in teaching in any of the educational institutions, within the State specified to be not lower in standard than that of a Secondary School is eligible to be included in the electoral roll. The list of Educational Institutions so specified is available with the officers mentioned in the First Schedule
- Every application in Form 19 by a person seeking enrolment in Teachers' Constituency shall be ac-companied by a certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years. The format for the certificate will be as follows:-

- In the case of a person who is not engaged in teaching on the date of application, the Certificate should be signed by the Head of the Institution, in which he last served.
- Applications in bulk whether submitted in person or by post, shall not be considered for inclusion by the ERO. However, the Head of the Institutions may forward the applications of all his staff together. One member of a family may also submit the Form 19 of other members of the same family and may get the certificate verified by producing original certificates in respect of each member.
- It should be noted that any person who makes a Statement or declaration in the application which is false and which he either knows or believes to be false, or does not believe to be true will be punishable under Section 31 of the Representation of People Act, 1950.
- 9. Printed applications of Form 19 may be obtained from the Offices of ERO/AERO/Designated Officers or Manuscript, typewritten, cyclostyled or privately printed forms will also be accepted.
