- All persons whose names are included in the existing rolls for these constituencies should also submit fresh applications in the prescribed forms, to enable the ERO to verify the present eligibility of the applicant in terms of Article 171(3)(c) of the Constitution read with Sections 27(3)(c), 27(5)(b) and 27(6) of the Representation of
- Qualifications: Every person who is a citizen of India, and is ordinarily resident in the constituency and has, within the six years immediately before 1st November, 2012, been engaged for a total period of at least three years in teaching in any of the educational institutions, within the State specified to be not lower in standard than that of a Secondary School is eligible to be included in the electoral roll. The list of Educational Institutions so specified is available with the officers mentioned in the First Schedule.
- Every application in Form 19 by a person seeking enrolment in Teachers' Constituency shall be accompanied by a certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years. The format for the certificate will be as follows:-
