I am to invite your attention to the references 1st and 2nd cited.

2. In the reference 3rd cited, Collector Kurnool has sought for a clarification with regard to the procedure to be followed in assigning of numbers to the new Polling Stations in the Assembly Constituencies notified by Delimitation Commission.

3. In the proforma enclosed to the reference cited the polling station number has been left blank. This number has to be allotted by the Collectors based upon geographical considerations. Though the Polling Station will remain the same, it will have a new number in the new Constituency as per the DLC notification. It is necessary that the new numbers are allotted to polling stations in such a manner that the creation of routes, zones, etc., during the election is convenient. Collectors may, therefore, allot Polling Station numbers in the new Constituencies keeping the following points in mind.

- 1. The routes along which the polling stations lie.
- 2. The different routes clubbed into a zone.
- 3. The need to group Polling Stations in one mandal together for administrative convenience.

4. Based on these points, new Polling Station numbers in new Constituencies should be allotted to the existing Polling Stations in the existing constituencies. Statement No.II must clearly bring out the mapping between old polling station number and new polling station number. To ensure this, please fill up enclosed Statement IV prior to filling up Statement II. This statement provides a detailed reconciliation for every polling station in the District. A sample page of statement IV is also enclosed. After Statement No.IV is filled in carefully, all polling stations in the district will be accounted for. Based upon Statement No.IV, Statement No.II can then be filled in.

5. Please ensure that this information completely verified and certified by you in those formats. (Statement I & II enclosed earlier and Statement No.IV) enclosed now reaches me by 29/02/2008.
