In pursuance of the re-poll ordered by the Election Commission of India, New Delhi vide reference 2nd cited, in the Polling Station No.119 of 83-Kalwakurthy Assembly Constituency in Mahabubnagar district, the Collector & District Election Officer, Mahabubnagar district is hereby authoriesed to declare local holiday on the day of re-poll i.e., 19.05.2014 (Monday) in the area of the above said Polling Station in connection with the conduct of re-poll on 19.05.2014.

- 2. The Labour, Employment Training & Factories Department is requested to declare a paid holiday on the day of re-poll i.e., 19.05.2014 (Monday) under the A.P. Factories and Establishments Act, 1974 (AP Act No.32/1974) and A.P. Shops and Establishments Act, 1988 read with the provisions laid down in Section 135-B of the Representation of the People Act, 1951 so as to enable the workers to exercise their franchise. Regarding the Industrial Undertakings / Establishments which are working on shift basis, it is clarified that a holiday may be declared only for the shift during which the poll is to be taken, in view of the clarification issued by the Election Commission of India, in its letter No.78/99/PLN-1, Dt:06.04.1999.
- 3. The Commissioner of Labour, A.P., Hyderabad is requested to declare a closed holiday on the day of re-poll i.e.19.05.2014 (Monday), if there is no holiday under the A.P. Shops and Establishments Act, 1988 (Act 20/1988) read with provisions laid down in Section 135-B (4) of R.P. Act, 1951, so as to enable the electors working in such shops, establishments to exercise their franchise.
- 4. The Municipal Corporations, Municipal Councils and other Local Bodies and every University established by Central or State Act may also observe local holiday to be declared by the Collector & District Magistrate, Mahabubnagar as authorized by the Government, on the day of re-poll i.e., 19.05, 2014 (Monday).

5. It is also directed that, as clarified by the Commission vide their letter 1st cited, in the case of employees who are ordinarily resident in the area where re-poll is on 19.05.2014, but having the place of work out side the poll area, and there is no re-poll in respect of the place of residence, those electors including casual workers working outside the re-poll area concerned would be entitled to the benefit of a paid holiday extended under the Section 135B(1) of the Representation of People Act, 1951, although his/her office does not happen to be closed on that particular day. The daily wage/casual workers are also entitled for a holiday and wages on poll day as provided in Section 135B of the Representation of People Act, 1951.
