Sir,

I am directed to refer to your e-mail dated 15.04.2014 on the subject cited and to state that your request dated 01.04.2014 received here on 11.04.2014 and another request dated 08.04.2014 was received here on 10.04.2014 through e-mail, for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968, for allotment of the said symbol 'Lion' to the candidate being set up by your party for the ongoing general election to the Legislative Assembly of Andhra Pradesh, 2014 in the 30- Manakondur (SC) Assembly Constituency ( which is going for poll as per Schedule 7) **has not been accepted** by the Commission as the same is **time-barred**. The application has been received in the Commission after the expiry of the stipulated time-period prescribed as per the provisions of para 10 of Election Symbols (Reservation and Allotment) Order, 1968.

2. In view of the above, concession for using the symbol "Lion" in the above mentioned Assembly Constituency has not been granted. Allotment of symbol to the Party's candidate in the said constituency will be governed by the provisions of paragraph 12 of the Election Symbols (Reservation & Allotment) Order, 1968.
