However, it is clarified that in phase-wise election it may not be possible to determine in the first phase itself whether the party has set up candidates from minimum numbers of constituencies or not. In such cases common symbol may be allotted to the candidates of such parties in the first phase. In case taking into consideration the candidates set up to the last phase, it is found that the party has not set up candidates in minimum no. of seats, common symbol to the remaining candidates of the said party will not be allotted and symbol to their remaining candidates in that phase will be allotted under the provisions of Paragraph 12 of the Symbols Order, 1968.
