

Sir,

I am directed to refer to your letter no. 3150/Elecs.D/2018 dated 27.10.2018 regarding fixing of the Hours of Poll in the State of Telangana and to inform you that the Commission has approved your proposal made therein and has fixed 7:00 AM to 5:00 PM, as the hours of Poll, in all ACs except in thirteen (13) LWE-affected ACs, as mentioned in above said letter and has fixed the hours of Poll from 7:00 AM to 4:00 PM for the election in respect of thirteen (13) LWE-affected ACs.

2. **You are also requested to ensure that Hours of Poll are duly publicised in respective Assembly Constituencies to reach out to all voters and 'PVS (Photo Voter Slip)' must reflect Hours of Poll in 'BOLD'. This may be brought to the notice of DEOs/ROs concerned of the State.**

3. In addition, I am to forward herewith, in advance, the Commission's Notifications issued under Section 30 and 56 of the Representation of People Act, 1951 and to request that necessary arrangements may kindly be made for their publication in an extraordinary issue of the Telangana Government Gazette on 12th November, 2018.

4. The sequence for the publication in the Gazette will be as follows:

- (i) Notification of the Governor of the State under Section 15 (2) of the Representation of the People Act, 1951 for the date 12th November, 2018
- (ii) Notification of the Election Commission of India u/s 30 and 56 of the said Act, dated 12th November, 2018.

5. Six copies of the Gazette containing the above mentioned notification may be sent to the Commission for its record.
