Instruction of use of Electronic Voting Machines (EVM) with Voter Verifiable Paper Audit Trail (VVPAT) system-regarding.

Sir/Madam,

I am directed to refer to the Commission's letters cited under references and to state that the some of the States have sought some clarifications regarding counting of votes:

- 1. In case counting of votes of VVPAT paper slips in respect of those polling stations where more than one VVPAT were used, is required to be done, in such case whether VVPAT paper slips of each VVPAT will be counted one by one or by mixing VVPAT paper slips of all VVPATs used in that particular polling station.
- 2. whether for mandatory verification of VVPAT Paper Slips of randomly selected one polling station of each Assembly Constituency/one polling station of each Assembly Segment of Parliamentary Constituency, the polling station(s) whose VVPAT paper slips have already been counted due to non-display of result from Control Unit (s) or under Rule 56(D) of the Conduct of Elections Rules 1961 are also to be included for randomization or not.

In this regard it is clarified that

In case counting of votes of VVPAT paper slips in respect of those polling stations where more than one VVPAT were used, is required to be done, in such case VVPAT paper slips of each VVPAT will be counted separately, one by one and result of each VVPAT will be entered in the attached Annexure-VII (separate Annexure-VII shall be used for each VVPAT) attached to Form 17C. Thereafter, a Final Result sheet shall be prepared by combining all results of that particular polling station and the same shall also to be attached to Form 17C.



NOTE: Annexure-VII of the Commission's letter No. 51/8/VVPAT/2017-EMS, dated 05/12/2017 shall be treated as withdrawn. Henceforth, revised Annexure-VII attached with this instruction shall be used.

ii) For mandatory verification of VVPAT Paper Slips of randomly selected one polling station of each Assembly Constituency/one polling station of each Assembly Segment of Parliamentary Constituency, the polling station(s) whose VVPAT paper slips have already been counted due to non-display of result from Control Unit (s) or under Rule 56(D) of the Conduct of Elections Rules 1961 or whatsoever the reasons, will not be included for randomization for that purpose.

The above instructions shall be brought to the notice of all concerned.
