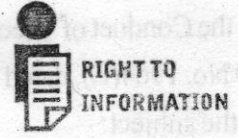

No. 52/2023/SDR/Vol.I,- In pursuance of the provisions of clause (c) of Section 60 of the Representation of the People Act, 1951, the Election Commission hereby specifies that the Covid-19 suspect or affected person, certified by competent authority, who applies for voting by postal ballot paper, and subject to verification of his request by the Returning Officer concerned, would be a class of persons to give his vote by postal ballot in the ongoing general elections to the Legislative Assemblies of Mizoram, Chhattisgarh, Madhya Pradesh, Rajasthan & Telangana and bye election in 43-Tapi (ST) Assembly Constituency of Nagaland, to be notified under Section 30 of the Representation of the People Act, 1951, as per the provisions in Part -III A

of the Conduct of Elections Rules, 1961, as amended vide Ministry of Law & Justice, Govt. of India, Notification SO No. 1964(E), dated 19th June, 2020 read with the directions and guidelines issued by the Election Commission on the subject.
