The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110001, Dated: 12th May, 2022, Vaisakha, 22, 1944 (Saka) is republished:-

#### **NOTIFICATION**

No.100/CS-TL/12/2021(1):- WHEREAS, the seat of Dr. Banda Prakash, in the Council of States, elected by the elected members of the Legislative Assembly of Telangana, has become vacant on 04.12.2021 by the reason of his resignation, before the expiration of his term of office which was up to and including 02.04.2024; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW. THEREFORE, in pursuance of Sectoion 147, sub-section (1) of Section 39 and Section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

- (A) Calls upon the elected members of the Legislative Assembly of Telangana to elect, before 01st June, 2022 and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Council of States;
- (B) appoints, with respect to the said election;
  - (a) The 19th May, 2022 (Thursday), as the last date for making nominations;
  - (b) the 20th May, 2022 (Firday), as the date for the scrutiny of the nominations;
  - (c) the 23<sup>rd</sup> May, 2022 (Monday), as the last date for the withdrawal of candidatures;

- (d) the 30th May, 2022 (Monday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 01st June, 2022 (Wednesday), as the date before which the election shall be completed; and
- (C) Fixes the hours from 09:00 am to 04:00 pm, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
