With reference to the above, I submit that our Party is recognized as State Party in the state under the Election Symbols [Reservation and Allotment] Order, 1968. Our party is maintaining Books of Accounts and getting the same audited by a Chartered Accountant and the return of income under the provisions of Income Tax Act, 1961 filed within the time limits and a copy of the audited accounts filed with the Election Commission of India:

Return of Income for the financial year 2013-14 has been filed. The election expenditure pertaining to the Elections for Lok Sabha and A. P. Legislative Assembly 2014 are partly incurred during the financial year 2013-14 and the remaining during the subsequent financial year 2014-15.

A total sum of Rs. 8,83,000/- has been incurred by the Party during the financial year 2013-2014 and another sum of Rs. 30,47,162/- incurred during the financial year 2014-2015. Thus, a total sum of Rs. 39,30,162/- spent on the elections by the Party.
