Sub: Candidates' booths(kiosks) outside the polling station:-accounting of expenditure incurred, in the account of election expenses of the candidate-reg.

Sir/Madam,

I am directed to refer to the Commission's instruction No. 76/Instructions/EEPS/VoI-XIX dated 30.12.2014 (Annexure-95 of Compendium of Instructions on Election Expenditure Monitoring - September, 2016), on the subject cited and to say that in supersession of para 1 of the above said instruction, the Commission, on further examination of the relevant provisions of section 77(1) of the R. P. Act, 1951, has decided that the candidates' booths set up outside the polling stations should hereinafter be deemed to have been set up by the candidates as part of their individual campaign and not by way of general party propaganda and as such all expenditure incurred on such candidates' booths shall be deemed to have been incurred/authorized by the candidate/ his election agent so as to be included in his account of election expenses(not falling under exempted category). The DEOs may be asked to notify the rates of the candidates' booths(kiosks) set up outside the polling stations(10 ft.X10 ft. enclosure with shade, two chairs and one table including the notional expenses on daily allowances and refreshment etc. to the party workers manning those kiosks) after due consultation with the political parties as envisaged in Paras 14.2 and 14.3 of the Compendium of Instructions on Expenditure Monitoring, along with other items of expenditure used for election campaign. The schedule 6 of account of election expenses to be submitted by each contesting candidate has also been modified accordingly (copy enclosed).

The DEOs should also give wide publicity of these instructions as SVEEP activity. The modification in the instructions referred to above may kindly be incorporated accordingly and may also be brought to the notice of all the officers concerned and the political parties. The candidates may also be informed by the R.O concerned at the time of filing of nomination.

Sub: Guidelines for dealing with candidates' advertisements channels/newspapers owned by political parties or their functionaries/office bearers during elections-regarding

Sir/Madam,

Please refer to the Commission's letter No. 491/Media/2011 (Advt.) dated 16th August, 2011 (copy enclosed), on the subject cited. In continuation of this letter, I am directed to convey that the Commission, after taking into consideration various references/ complaints from various sources in the above matter, has further directed that if the candidate(s) or their sponsoring parties utilize TV/Cable Channel/Newspaer owned by them for promoting the electoral prospects of the candidate, the expenses for the same as per standard rate cards of the channel/newspaper have to be included by the candidate concerned in his Election Expenditure Statement in the column made for this purpose (Schedule 4A of Annexure-15 of Compendium of Instructions on Election Expenditure Monitoring), even if, they actually do not pay any amount to channel/newspaper.

- The Media Certification and Monitoring Committee (MCMC) shall keep a close watch on the contents telecast on such channels to identify contents of the nature mentioned in para 1 above, and after following all due procedures, the notional expenses as per standard rate cards of the channel shall be added in the election expenditure account of the candidate appropriately.
- This instruction should be read together with the Commission's earlier instruction no. 491/Media/2011 (Advt) dated 16th August, 2011.
- The modified schedule 4 & 4A are also enclosed herewith. This may be brought to the 4. knowledge of all concerned immediately. This may also be brought to the notice of the contenting candidates at the time of filing of their nominations.

- (a) copy of the order containing list of all vehicles for which permit issued by the Returning Officer to be enclosed.
- (b) If the vehicle is owned by the candidate/his relative/agent are used for election purpose, notional cost of hire of all such vehicles, except one vehicle if owned and used by the candidate, notional cost of fuel and drivers salary for such vehicle, shall be included in total amount of expenditure in the above table.
- 2. In all schedules if any expenditure on goods and services, provided by the Political Party; or provided by any person/ company/ firm /associations/ body of persons etc. on behalf of the candidate, then the notional market value of such goods or services are to be indicated, in respective columns.
- 3. In Part –III, the Lump-sum amount of fund received from the political party or others or the candidate's own funds, should be mentioned date wise. In all such cases such amounts are required to be first deposited in the bank account of the candidate, opened for election expenses.
- 4. Each page of the Abstract Statement should be signed by the candidate
