#### NOTES TO ACCOUNTS:

- 1) The books of accounts of the Party were closed for the Current Period for the period ended 31st March 2018. As the Party was Registered as a Political Party by the Election Commission of India with effect from 24-11-2014, the Accounts were prepared from the date of Registration of the Party only i.e. 24-11-2014. Accordingly the expenditures and the Receipts incurred prior to the registration of the Party were not considered.
- 2) The Party follows the Accrual system of Accounting and as a on going concern basis. The Accounting policies are consistent with generally accepted accounting principles.
- 3) No provision of gratuity to employees has been provided during the year as no employee has yet to put in the qualifying service.

#### 4) ACCOUNTING POLICIES ADOPTED:

#### i. **FIXED ASSETS:**

Fixed Assets are considered at their cost of acquisition inclusive of taxes, duties, freight and other incidental charges thereon.

#### ii. **DEPRECIATION:**

Depreciation has been provided for the current period as per Income Tax Act.

#### **INCOME & EXPENDITURE:** iii.

The expenditure was considered on accrual basis. But the income was considered on Receipt basis.
