Attention of all the District Collectors & District Election Officers and the Commissioner, GHMC & District Election Officer, Hyderabad is invited to the references cited (copies enclosed) wherein the Election Commission of India has informed that following 2 recognized State parties in the States mentioned having said reserved symbols in the said state, have requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbols to their candidates being set up by the said parties at the current general election to the Legislative Assembly of Telangana in all the assembly constituencies.
